5. Security: Enhance security by identifying and preventing fraudulent or unauthorized activities.

3. Types of Cookies We Use

We use the following categories of cookies:

 Essential Cookies: Necessary for the basic operation of Unicorn Tap.

• Performance Cookies: Collect information about how users interact with the game to help us improve functionality.

• Functional Cookies: Remember your preferences, such as language settings or gameplay preferences.

 Advertising Cookies: Used to deliver personalized advertisements and track their effectiveness.



4. Third-Party Cookies

We may allow third-party service providers, such as analytics and advertising partners, to place cookies on your device when you interact with Unicorn Tap. These third parties may collect information about your online activities across websites and apps.

• Legal Compliance: We may disclose your personal data if required to do so by law, regulation, or legal process, or if we believe such action is necessary to comply with a legal obligation, protect our rights, investigate fraud, or respond to a government request.

• Service Providers: We may use third-party service providers to facilitate certain aspects of the Game (e.g., hosting services, analytics), but these providers are not allowed to use your personal data for any other purposes. We ensure that they comply with privacy and data protection standards.

5. Cookies and Tracking Technologies
