# Terms and Conditions

**Last updated: 24.12.2024**

**These Terms and Conditions („Agreement“) govern your use of the Unicorn Tap („the Game“), a blockchain-based crypto tap-to-earn game running on the Ethereum blockchain, which allows users to earn Unicoin, exchange them for Ethereum ICO Tokens, and participate in various in-game activities. The Game is available for download via an APK file („the APK“). By downloading, installing, and using the Game, you agree to be bound by this Agreement. If you do not agree to these Terms, you must not download or use the Game.**

## **1. Acceptance of Terms**

**By accessing or using the Game, you agree to comply with and be bound by these Terms and Conditions, as well as any additional policies, guidelines, or updates we may release from time to time. This Agreement constitutes a legally binding contract between you („User“ or „Player“) and Unicorn Tap („We“, „Our“, „The Company“).**



## 2. Game Overview

**The Game is a decentralized, blockchain-based, tap-to-earn game built on the Ethereum blockchain. In the Game, users earn Unicoin by tapping and performing in-game activities. Unicoin can be exchanged for Ethereum ICO Tokens, which will be launched at the end of each season. Players can also use Unicoin to purchase in-game items, participate in leagues, complete quests, and acquire NFTs that hold real-world value.**

## 3. Account Creation and Eligibility

- **Account Creation:** To access the Game, you may need to create an account, including providing an Ethereum wallet address for transactions and storing any earned tokens, NFTs, or assets.
- **Eligibility:** You must not be located in a jurisdiction where participation in cryptocurrency-based activities or online gaming is prohibited or restricted.

## 4. Earning and Using Unicoin

- **Unicoin:** Players earn Unicoin by tapping in the Game. Each tap earns you one Unicoin. Unicoin are the in-game currency and can be used in the following ways:
  - **Exchanging for Ethereum ICO Tokens:** At the end of each season, players can exchange their Unicoin for Ethereum ICO Tokens. The ICO Tokens will be launched during the end of the season, and the exchange rate will be determined by the Company.
  - **Purchasing In-Game Items:** Unicoin can be used to buy various in-game items, such as skins, power-ups, or enhancements.
  - **Leagues and Quests:** Players can participate in leagues and quests to earn additional Unicoin.



- **ICO Tokens:** The Ethereum ICO Token represents a utility or access token that may have future value, but the Company does not guarantee any specific value. ICO Tokens will be distributed at the end of each season, and players will be able to exchange Unicoin for ICO Tokens at the exchange rate set by the Company.
- **Unicoins and Tokens Are Not Fiat Currency:** Unicoins and Ethereum ICO Tokens are not legal tender or fiat currency. They are digital assets that exist only within the Game and the Ethereum blockchain network.

## 5. NFTs (Non-Fungible Tokens)

- **NFTs:** The Game contains digital collectibles in the form of NFTs. NFTs can be earned, purchased, or traded within the Game. These NFTs may represent in-game items, characters, or assets with potential real-world value.
- **Ownership:** NFTs are owned by the player through their Ethereum wallet. All transactions involving NFTs are immutable and recorded on the Ethereum blockchain.
- **NFT Transactions:** When you buy, sell, or transfer NFTs, you are responsible for paying any associated gas fees and transaction costs on the Ethereum network.

## 6. In-Game Purchases

- **Purchasing In-Game Items:** You can use Unicoins to purchase various in-game items, including cosmetic items or upgrades, which may enhance your gaming experience but do not impact your ability to earn Unicoins or participate in the core gameplay.
- **No Refunds:** All in-game purchases, including purchases of NFTs, Unicoins, or other virtual items, are final and non-refundable, except as required by applicable law.



## 7. Blockchain and Ethereum Network

- **Ethereum Blockchain: The Game operates on the Ethereum blockchain. Any transactions involving Unicoin, ICO Tokens, or NFTs are processed through the Ethereum network. You are responsible for understanding the risks associated with blockchain technology and cryptocurrencies.**
- **Transaction Fees: When exchanging Unicoin for ICO Tokens, purchasing NFTs, or making any other transactions on the Ethereum network, you may incur Ethereum network fees („gas fees“). These fees are independent of the Game and are beyond the Company's control.**
- **Irreversibility: Blockchain transactions are final and irreversible. Once a transaction is confirmed on the Ethereum blockchain, it cannot be undone, reversed, or refunded.**

## 8. Prohibited Conduct

**You agree not to engage in any of the following activities:**

- **Fraudulent Activity: Attempting to exploit bugs, vulnerabilities, or any other means to manipulate the Game for personal gain.**
- **Botting or Automation: Using bots, automated scripts, or other forms of automation to generate Unicoin or manipulate in-game processes.**
- **Violation of Laws: Participating in the Game in a manner that violates any local, national, or international laws, including but not limited to those governing cryptocurrency, gaming, or online conduct.**
- **Impersonation: Pretending to be another user, including the Game's staff or other players.**



## 9. User Account Security

- **Account Responsibility:** You are responsible for maintaining the confidentiality and security of your account information, including your Ethereum wallet address and private keys. You agree to notify the Company immediately if you believe your account or wallet has been compromised.
- **Lost Funds:** The Company is not responsible for any loss of funds, NFTs, or tokens due to account compromises, lost private keys, or user errors.

## 10. Intellectual Property

- **Ownership:** All content, including game code, artwork, graphics, audio, NFTs, and any other intellectual property within the Game, is owned by the Company or its licensors.
- **License:** The Company grants you a limited, non-exclusive, non-transferable license to access and use the Game for personal, non-commercial use. You may not reverse-engineer, decompile, or otherwise attempt to extract the source code of the Game.

## 11. Risk and Disclaimers

- **Cryptocurrency and Token Risk:** Cryptocurrencies, including ICO Tokens and NFTs, are highly volatile. The value of the tokens and NFTs in the Game may fluctuate significantly, and there is a risk that you may lose some or all of your Unicoin, ICO Tokens, or NFTs.
- **No Guarantee of Value:** The Company makes no guarantee regarding the future value of ICO Tokens or NFTs. Participation in the Game does not guarantee any return on investment or future profits.
- **No Warranty:** The Game is provided „as is“ without warranties of any kind, whether express or implied. The Company does not guarantee the availability, functionality, or security of the Game.



## 12. Privacy and Data Protection

- **Data Collection:** The Game may collect certain personal information and data, such as device information, IP addresses, and usage data. Please review our [Privacy Policy] to understand how your data is collected, used, and protected.
- **Blockchain Transactions:** All transactions on the Ethereum blockchain are public and immutable. While the Company does not collect transaction data, you should be aware that your wallet address and transaction history may be publicly visible on the blockchain.

## 13. Modifications to Terms

The Company reserves the right to update or modify these Terms and Conditions at any time. Any changes will be posted on the Game's website or within the APK, and the updated Terms will be effective as of the date of posting. By continuing to use the Game, you agree to the updated Terms.

## 14. Governing Law and Dispute Resolution

These Terms shall be governed by the laws of Panama. Any disputes arising under or in connection with these Terms will be resolved through binding arbitration in Panama, in accordance with the rules of the Arbitration Association.
